#### PUBLIC SECTOR BONUSES AVAILABLE TO PEOPLES GAS CUSTOMERS

Introducing new rebates and incentives available to public sector customers in Peoples Gas territories. Public Sector customers are customers that are municipally owned by local and county governments. Program offerings valid through December 31, 2020.

#### As of August 26, 2020:

- 150% rebate increases available on projects submitted.
- Exclusions apply. Steam trap testing, steam and hot water boilers, and custom projects do not qualify.
- Up to 100 perfect of project cost or \$2,500 available for boiler tune-up projects (increase from \$1,500).
- Custom projects cap 100 percent of project cost (previously 75 percent cap).

- Municipal owned businesses
- Public education buildings
- Public parks
- City and government buildings/offices
- Public transportation centers
